PRODUCT DESCRIPTION

Liquid blend of ethanol as a majoritary component and flavours to make a food grade liquid, which is able to aromatize the inner face of a mask.

ORGANOLEPTICAL CHARACTERISTICS

Aspect	:	Liquid
Color	:	Colourless with a slightly turbidity
Taste/Flavour	:	Piña colada

RECOMMENDED DOSE

Aromatized liquid preparation to be sprayed directly onto the inner mask face, in order to aromatize the mask during some time. It is recommended to spray ones (aprox. 0,115 g. of liquid product) from a distance between 8 – 10 cm far from the internal face of the mask.

Before using the mask, it is recommended to wait, at least one minute, to give enough time to evaporate the alcohol.

Due to the high alcohol content, it is strongly recommended to do not spray this product near of hot points or even electrical sources that can light it.

In case of retail sales, it can be repack directly 100% into the final packing.

REGULATION

Each component in this blend accomplish with the norms and prescriptions of the EEC ("Regulation (EC) No 1334/2008 on flavourings" and "Regulation (EC) No 1333/2008 on food additives"). Nevertheless, we recommend to check each regulatory disposition at the countries where this product will be used and/or commercialised as a food grade aromatic.
